CLASSES

Separate classes for dogs and bitches except for Best of Breed and higher. Puppy 3-6mo, Puppy 6-12mo, Bred by Exhibitor, Open, Winners, Reserve Winners, Best of Breed and Best of Winners.

Purebred Companion Dogs – ONE CLASS – Sexes combined. (Purebred rescue dogs and all other purebred dogs not eligible to be shown in the regular breed classes or for any other reason.)

Junior Showmanship – Beginner 7-9yrs, Junior 10-14yrs, Senior 15-18yrs. Two Tiers – Novice and Open

Group & Best In Show Competitions

Groups will be judged immediately following the last breed in their respective Group.

RIBBON AWARDS

Ribbons for all classes. Rosettes for Group First Placements and Best In Show Winners.

DIRECTIONS TO SHOW

From Interstate 5, you can exit at either NE 45th Street (Exit #169) or NE 65th Street (Exit #171).

From the I-5 NE 45th Street Exit, go east on 45th, past the University of Washington, and down the 45th Street ramp. Continue East past University Village Shopping Center. Bear left and continue about 2 miles. You will pass Children's Hospital and Regional Medical Center and Sand Point Village/Princeton Avenue.

From the I-5 NE 65th Street Exit, head East approximately four miles on 65th (stay on the arterial!) until you have crossed Sandy Point Way NE into the NE 65th Street entrance to Sand Point Magnuson Park.

WHAT'S DIFFERENT ABOUT THE NCA?

RARE BREEDS. The NCA offers a *RARE BREED GROUP*. This will provide rare breeds an opportunity to gain championship and other titles through national all-breed events. Competition will be within the respective breeds with Best of Breed winners advancing to the *RARE BREED GROUP*. Group winners will advance to Best in Show.

PUREBRED COMPANION DOGS. (This is a dog show class only.)

The NCA believes **all dogs are created equal**. The NCA has established two categories for the purebred companion dog class:

- a) **PUREBRED RESCUE DOGS** – The NCA believes the individuals who own rescue dogs deserve special recognition and accommodations to meet their desire to participate in competitive events. Accordingly, the NCA has established a special registry and competition for these purebred rescue dogs. Purebred rescue dogs should be registered as such on Purebred Rescue Dog NCA Form #4 (not included in this announcement) and when competing at NCA events should be entered in the Purebred Companion Dog class.
- b) **PUREBRED DOGS WHO CANNOT BE SHOWN IN THE REGULAR CLASSES** – There are a number of reasons why a **properly registered purebred dog** cannot be shown in the regular classes for competition. Additionally, an owner may realize that their particular dog is not up to competing in the regular show classes. These purebred dogs should be registered on the enclosed Purebred Single Dog Registration Application NCA Form #1 and when competing at NCA events should be entered in the Purebred Companion Dog class.

Normally, there will be one class for purebred companion dogs to include dogs and bitches. However, when the number of entries within a particular Group warrants, the dogs may compete by Group. A *Recognition of Achievement* certificate will be awarded to a dog that has attained twenty (20) points from this class.

SPAYED OR NEUTERED DOGS. While the NCA values the role of the breeder, we believe the sport of dogs should be opened to more than just breeding stock. Therefore, properly registered purebred dogs, which have been neutered or spayed, are eligible to be shown and compete in the regular classes of their respective breed through Best of Breed, Group and Best in Show provided the breed standard does not specifically disqualify spayed or neutered dogs. (If the breed standard states spayed or neutered as a disqualification, these dogs may be entered in the Purebred Companion Dog class.)

CONCERNING NCA REGISTRATION OF DOGS

FOR THOSE DOGS NOT PREVIOUSLY REGISTERED WITH THE NCA – IT IS STRONGLY RECOMMENDED ELIGIBLE DOGS BE REGISTERED ALONG WITH DAY-OF-SHOW ENTRY or by mailing an NCA registration application (included with this event announcement) directly to the NCA. Dogs must be eligible for registration by being registered with one of the NCA recognized registries, i.e. American Kennel Club, Canadian Kennel Club, United Kennel Club, etc. **It is important to note that in order for the Winners D/B, BOB, Group and BIS winners to be awarded points toward their NCA championship, they MUST be registered with the NCA within twenty-one (21) days after the show date.** Registration applications are available on our web site www.nationalcanine.com, (click on “FORMS”) or by emailing ksawyer@nationalcanine.com. Submit with check to NCA, 5 Wagon Wheel Way, Ocala, FL 34482 or with your entries. You **MUST** attach a copy of the dog’s other registration papers, i.e. AKC, CKC, UKC, or any other NCA recognized registry. List **ONE OWNER**. Registration applications will also be available at the show.

PLEASE FEEL FREE TO PASS ON THIS INFORMATION TO ANY DOG RELATED LIST YOU ARE ON, OR ANY WEB SITE YOU MAY BE ASSOCIATED WITH. COPIES MAY BE MADE OF ENTRY FORMS AND NCA REGISTRATION APPLICATIONS.

“DAY-OF-SHOW” ENTRIES will be taken each day from 7:30 AM to 9:00AM for morning shows and 7:30 AM to 1:00PM for afternoon shows.

NCA CHAMPIONSHIP POINTS EXPLAINED

100 POINTS REQUIRED TO BE CERTIFIED AS AN NCA CHAMPION.

THE AWARDING OF POINTS IS CUMULATIVE, whereby one (1) point is awarded for each Dog/Bitch defeated with a **minimum** five (5) points for WD/WB. A **maximum** of thirty-five (**35**) points awarded at any one show. A non NCA champion Group winner receives one (1) point for every dog/ bitch competing within the Breed classes in their respective Group up to thirty-five (35) points. Second place winner receives one (1) point for every dog/bitch exhibited in the breeds within the Group minus the number of dogs/bitches exhibited in the breed of the Group winner. Third place winner receives one (1) point for every dog/bitch exhibited in the breeds within the Group minus the number of dogs/bitches exhibited in the breeds of the first and second Group winners. Fourth place winner receives one (1) point for every dog/bitch exhibited in the breeds within the Group minus the number of dogs/bitches exhibited in the breeds of the first, second and third place Group winners.

Instructions For Front Corresponding # in ()

- (1) VARIETY - If a dog is entered in a breed which has a variety, you must designate the variety.
- (2) CLASS - Puppy (6-12mo), Bred by Exhibitor (dog must be handled by the breeder, co-breeder or immediate family member), Open (for all dogs of the respective breed over the age of six months) and Best of Breed (for NCA champions of record and Winners Dog/Bitch on the day). Any dog or bitch that has attained its NCA championship may be shown in Best of Breed competition. Dogs or bitches who have attained their championship, according to their owner's records and who have not received official notification from the NCA, may be shown for a period of 120 days in Best of Breed Competition. Junior Showmanship – Beginners 7-9yrs, Juniors 10-14yrs, Seniors 15-18yrs. Two Tiers – Novice and Open. Novice, for any child not winning three first place awards, with competition. Open, for any child who has received three first place awards, with competition.
- (3) OWNER – A dog must be entered in the name of the individual who actually owned the dog at the time entries closed for this event. List **ONE** owner only.

Agreement

I acknowledge that the "Rules and Regulations for NCA Canine Registrations and Performance Events" have been made available to me, and that I am familiar with them. I agree that the club holding this event or the NCA has the right to refuse this entry for cause which the club or NCA shall deem to be sufficient.
